Gift Aid is a very simple initiative that allows charities like the Gillingham Local History Society to reclaim tax paid on donations. This can be as much as 25p in the £ but costs you nothing (apart from a few moments of your time).

By completing this form, you are informing us that you pay tax in the UK (income and/or capital gains) at least equal to the tax we can reclaim on your donations in the tax year (currently 25p for each £1). If you pay tax at a higher rate you can claim further tax relief in your Self-Assessment tax return.

This is a once in a life time declaration that will cover all donations from the date below. All we ask is that you notify us in writing if you change your name and address or if your circumstances change and you no longer pay tax. You may also cancel this declaration at any time.
